## Wednesday, March 20, 2024, 10:00 AM

This meeting was held at Station 810, 33900 West Street, Albion, CA and via videoconference on the Zoom platform.

- 1. **Call to order and determination of a quorum.** The meeting was called to order at 10:05 am by President Greenberg. Directors Acker, Greenberg, Welty, Linstedt and Christensen were present at Station 810. Also present Wendy Meyer, Chief Rees, Susy Kitahara and Carolyn Latkin on zoom.
- **2. Motion by Secretary Steve Acker to adopt agenda:** Approved by a board vote of 5 ayes.

  - **a. Building Committee:** The foundation for new door repair at station 811 is complete. The posts have been fixed. Demolition nearly complete. New apron slab is needed. Planning Commission hearing for Station 810 project CDP set for April 4. Support Letters can be submitted by April 3.
  - b. Treasurer's report: Welty: Check for \$30K from 22/23 Prop. P received. TOT money will be coming in.
  - c. Finance Committee: Welty Final budget approved by a board vote of 5 ayes. (see packet)
  - **d. Resource Committee Greenberg:** Letter to go out. Letter was sent to the CPUC regarding ATT's intent to discontinue service as "carrier of last resort" to our area.
  - e. Grants, Fire safe council, LAFCO Christensen: SCBA grant will be resubmitted. Fire Safe Counsel NEAR PG&E grant is due March 31 and executed by August 31. \$100K for brush clearing and tree removal 500 ft. from facilities and lines. The Community Wildfire Protection Plan was submitted to the Board for Board approval.
  - **f. Fire Tax Ad Hoc Committee:** Members needed for Fire Tax campaign committee that are independent of the board.
  - **g. Auxiliary:** St. Patrick Dinner at the Grange proceeds: \$3055 total. \$1507.50 expenses. \$1547.50 to the Fire District.
  - **h. Safety Committee:** Wendy will lead. Acker, Christensen, (Linstedt) with Fire Fighter and Auxillary members.
